As per Govt. letter communicated vide Memo No. HMA.46/2010/235-A, dated 13th October/2011, Officers in the rank of Inspector of Police are not permitted to appear in the Half Yearly Departmental Examination conducted by the Commission for IAS/IPS/ACS/APS etc. Officers till they are promoted to APS Junior Grade.

Non-Gazetted Police Officer will appear at the examination to be held at the Headquarter of the District in which they are serving under supervision of a separate local Examination Board in each District, which shall be conducted simultaneously with the examination on Police Law and Languages of the Half Yearly Departmental Examination.
