1.1 The Assam Public Service Commission is going to present its Annual Report for the year 2010-2011.

COMPOSITION OF THE COMMISSION

- 1.2 The Assam Public Service Commission was set up under Article 318 of the Constitution of India. The first Composition of the Commission and Staff, their tenure of office and condition of service come into force with effect from first day of September, 1951.

FUNCTION:

1.5 The Assam Public Service Commission has to discharge the duties and functions specified in Article 320 of the Constitution. Commission is required to advice Govt. on all matters relating to framing of Recruitment Rules, Principles to be followed in making appointments, promotions & in respect of the disciplinary matters affecting Civil Servants. Recruitment to the Assam Civil Service and other allied categories are made through the Combined Competitive (Preliminary and Main) Examinations. The Assam Public Service Commission is required to be consulted in the matters of Recruitment, Promotions; Disciplinary matters framing of Recruitment Rules and other service matters

of the Assam State Services (Namely ACS, APS, AFS, A.E.S.S. Ranger Course in Forestry, B.D.O. etc.). The Commission is also to be consulted in respect of appointment to certain categories of post of Municipal Corporation of Assam and some other organizations under the provisions of Article 321 of the Constitution.

FINANCIAL MATTERS:

1.6 The Commission derived an income of Rs. 17,125/- (Rupees seventeen thousand one hundred twenty five) only. The main source of income was mostly from various Application fees, Examination fees etc. in connection with the various post advertised.

The total expenditure of the Commission was Rs. 5,78,23,301.00 (Rupees five Crores seventy eight lakhs twenty three thousand three hundred and one) only. Details information relating to financial receipts and expenditure during the year 2010-11 were shown in Appendix-II.

1.7 The Secretariat of the Commission is located in its own building (incomplete) at Jawaharnagar, Khanapara, Guwahati-22.

1.15. It comes to Commission's notice that the offer of appointment to candidates recommended by them on the basis of written examination/ Direct Recruitment by Interview and in case of promotions were delayed in several cases by the concerned Department during the year under report. (Details in Appendix-IV).

EXAMINATION WING

1.16. The Commission is continuously engaged in pre-interview programmes for various posts and also reviewing the examination and interview methodology and other allied matters. The Commission have introduced objective type tests in many of their Examinations for which a "Question Item Bank" in various discipline is maintained confidentially, for utilization in case any such need arises.

INSTALLATION OF THE INTELLIGENT CHARACTER RECOGNITION (ICR) BASED EXAMINATION AUTOMATION SYSTEM.

1.17. The intelligent character recognition based examination automation system of the Commission was inaugurated by Shri Tarun Gogoi, Honb'le Chief Minister of Assam on 24th Feb, 2011.

This system automatics every step of existing examination process right from processing of application to preparation of result sheet and will place checks in every step to eliminate common errors.

The system has the intelligence of verification and validation of each records with less human in intervention, making it an error free unbiased process. Also the time taken by the system is much lesser than the manual processing.

The installation of the above system based on advanced technology would go a long way to further the cause of maintaining high degree of transparency and professional efficiency of the Commission.

1.18. The total number of applications received shown in correspondence column does not tally with the total number of application received for recruitment by Examination and Interview is due to the fact that Examination and Interview could not be held for all the posts advertised during the year.

CHAPTER-II

RECRUITMENT BY EXAMINATION

A. GENERAL OBSERVATION ON THE METHOD OF RECRUITMENT THROUGH EXAMINATION.

Revision of Scheme and Syllabi for Combined Competitive (Main) Examination.

2.1 In order to take into account new developments the Commission has adopted a continuing process of reviewing the selection process. The Scheme and Syllabi of various Examinations including the Combined Competitive (Main) Examination were revised by the Commission in Consultation with academic experts. The revised syllabi for Combined Competitive Examination has been in corporate in the rules of the Combined Competitive Examination.

NEED FOR PROPER ASSESSMENT OF VACANCIES

2.2 The Commission regrets to state that inspite-of repeated observation made by them in their earlier reports. Cases continued to occur where some of the Departments did not intimate the actual number of vacancies for being included in the Commission's notice of the Examination/Interviews for the information of the prospective candidates. As a result in respect of some of the Examination/Interviews the number of vacancies notified initially in the notices issued by the Commission did not bear any resemblances to the number of vacancies finally reported for being filled on the result of those Examinations/Interviews.

USE OF INDIAN LANGUAGE IN COMBINED COMPETITIVE (MAIN) EXAMINATION.

2.3 In the Combined Competitive (Main) Examination the candidates have to answer in

the medium of English in all papers including General Studies.

However those candidates who opt. to write in Assamese in optional papers are also allowed to do so.

EXAMINATION WINGS

- 24 The conduct of various Competitive Examination for selection to various services and posts being one of the Principal activities of the Commission great importance is attached to the quality, efficiency and reliability of the Examination process. This necessitates a constant monitoring of the Examination process, methodology and allied matters to facilitate this an Examination Confidential Wings has been set up by the Commission. The Commission maintains contact with other recruitment agencies, academic experts concerned with a view to keep abreast of the latest development in Assam and elsewhere in the field of Examination.
- 2.5 The Examination Confidential Wings has been instrumental in enabling the Commission to switch over smoothly from the conventional essay type to objective type papers in the Combined Competitive (P) Examination etc. This has helped the Commission to cope with the phenomenal increase in the number of candidates appearing the aforesaid Examination besides ensuring total objectivity in the evaluation process and timely declaration of result.

B. EXAMINATION HELD DURING THE YEAR

2.6 No Examination was held during the year.

SAILENT FEATURE OF DIFFERENT EXAMINATION. HALF YEARLY DEPARTMENTAL EXAMINATION

2.7. The half yearly Departmental Examination for Officers belonging to I.A.S., A.C.S. and various Officers of other Departments Held from 19th July, 10 to 22nd July, 10 in 4(four) centres, viz- Guwahati, Jorhat, Tezpur, and Silchar. The Tribal Language Examination i.e. Bodo, Karbi, Mishing, Dimasa, Khasi, Kuki, Garo and Hamar were held on 1st Aug, 10 at Guwahati Centre only. All together 950 officers applied for appearing in various subjects for the said examination and the result of both examination were announced on 1st Dec,10 separately, 462 officers passed in various subjects and 14 Officers in Tribal Language.
