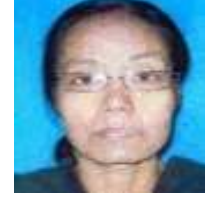

- 3) Caste Certificate (SC/ST(P)/ST(H)/OBC/MOBC) in original issued by competent authority wherever applicable.
- 4) Up-to-date Identity card/disability certificates in original in case of PWD candidates only issued by competent authority.
- 5) Any other Certificates/Documents that may be relevant for your candidature.

Canvassing in any form either to the Chairman or Members of the Commission in respect of your candidature shall be treated as a disqualification.

It should be noted that your application for the above mentioned post will remain under scrutiny of the Commission and as such your candidature is liable for rejection, if any wrong information furnished by you in your application is detected at any stage even after the interview also.
