This is for information of all concerned candidates that the Screening Test of BDO under P & RD Deptt. will be held on 08/10/2017 in Guwahati. The following instructions are issued to candidates to follow in order to ensure smooth conduct of the examination.

**Do's -**

1. Enter the Examination Hall 30 minutes before the commencement of examination.
2. Bring the e-admission certificate, valid identity proof containing photograph and black ink ball point pen.
3. The E- Admission certificate will be used as attendance sheet. Please download two copies of the certificate and keep one with you for future use.
4. **Paste a recent passport-size photograph with white background on the space provided in the e- Admission certificate and hand over the copy of e- Admission certificate to the Invigilator at the Examination Hall after signature on the space provided.**
5. Candidates must bring any one of the valid identity proof documents such as, PAN Card/ Driving License/ Voter ID Card/ Bank passbook containing photograph/ ID card issued by the Educational Institution where the candidate is studying presently / ID card issued by the Govt. or Public Sector Undertaking/passport etc.

**Dont's -**

1. **THE PROHIBITED ITEMS SUCH AS ELECTRONIC COMMUNICATION DEVICES INCLUDING MOBILE PHONE (EVEN IN SWITCH OFF MODE), BLUETOOTH, EARPHONE, TABLET, CALCULATORS, BOOKS, SCALE, OR DRAWING INSTRUMENTS ARE NOT ALLOWED INSIDE THE EXAMINATION HALL. THERE WILL BE NO ARRANGEMENT FOR KEEPING THE MOBILE PHONES OR OTHER GADGETS AT THE PREMISES .DO NOT BRING THEM TO THE EXAMINATION CENTRE.**
2. Once inside the Examination centre premises, the candidates should debar themselves from any unauthorized activity which will attract penal action as per rule.
3. No candidate will be allowed entry 20 minutes after commencement of examination.
4. No discussion is allowed inside the examination hall. Discussion etc. amounts to adoption of unfair means in examination and necessary action as per rule will be taken.
5. Smoking or taking refreshment inside the Examination hall is strictly prohibited.
