In the meantime, the approval accorded for filling up of another 04 (four) Nos. of sanctioned vacant posts of Junior Administrative Assistant in the office of the Assam Public Service Commission was received from Government vide letter No. ABP.56/2020/Pt/47 dated 11th March/2022.

The Commission has decided to combine the selection for the above mentioned posts i.e. the earlier 13 (thirteen) posts vide advt. no. 01/2022 and 04 (four) additional posts, totaling 17 (seventeen).
