RE-AUCTION NOTICE

2. Accordingly, sealed quotations affixing court fee stamp of Rs.8.25(Rupees Eight and twenty five paisa) only are invited for disposal of the said vehicle on the terms and conditions mention below. Person/firms, interested in purchasing the above mentioned vehicle, may submit their highest bid in the enclosed Proforma in a sealed cover addressed to the undersigned latest by 3.00 PM on or before <u>24th July/2019</u> at the Office of the Assam Public Service Commission, Jawaharnagar, Khanapara, Guwahati-781022, and will be opened on the same day at 4.00PM. The bidder or their representatives, not more than one for each quotation, may be present, if they so desire, at the time of opening of Quotations. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLE".

3. The vehicle will be available for inspection between 3.00 PM to 5.00 PM from 9th July to 23rd July/2019 in presence of the In-Charge, Pool, APSC.

4. The Auction of the said vehicle will be governed by the following conditions:-

i. The vehicle will be sold on "as is where is basis". The auction process will be conducted in presence of the constituted Condemnation Board.

ii. The bidders are required to pay Earnest Money of Rs. 2000.00 (Rupees Two thousand only) .

iii. Earnest Money is payable by means of Demand Draft drawn in favour of **"Secretary, APSC"**. (payment by cheque or cash shall not be accepted)

iv. Quotations received without demand draft towards Earnest Money will not be considered and shall be rejected.

v. The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Secretary, APSC.

vi. The Earnest Money of the successful bidder will be released only after the deposit of the bid amount. Earnest Money will not be adjusted as bid amount and will be forfeited, if he fails to honor the bid. In case of failure to deposit final bidding amount, the respective vehicle may once again be taken up for re-auction.

vii. On submission of application by the unsuccessful bidder EMD will be refunded within one month after completion of the process.

viii. The delivery of the auctioned vehicle will be arranged only after the successful bidder submits documentary evidence in support of the residential status (PAN Card, ID proof etc. in case of individual and Registration Certificate etc. in case of firms).

ix. The auctioned vehicle will be removed by the successful bidder within 02 working days of depositing the bid amount, at their own expenses.

x. The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by this department.

xi. This Department will not owe any responsibility for transfer of vehicle and for any other liability for using these vehicle for commercial or any other purpose after sale.

xii. The successful bidder will also be responsible for getting Registration Certificate of the Vehicle and/or any other documents as required by the RTO, in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

xiii. The bidder will not be allowed to withdraw their bids and if they do so their earnest money will be forfeited.

xiv. The Bid amount is excluding GST, as the GST is to be paid by the recipient of the goods as per the rates applicable.

xv. The Board reserves the right to accept or reject any/all of the quotation without assigning any reason.
