Details of Tender:

- 1) The attendance sheets should be printed in duplicate on legal-sized paper, including the photo and signature of each candidate. Seat labels should be printed on sticker paper. Additionally, the printed attendance sheets and labels must be packed according to the venue and examination session.
- 2) The Printing of attendance sheet and labels will be based on examination wise. There shall be work order before each examination and the selected firm will have to submit the printed attendance sheet and labels on or before 7 days of the date of examination.
- 3) The candidate's data will be provided to the concerned firm before examination via email only.
- 4) The format of attendance sheet shall be provided by this office.
- 5) The printed document must be submitted to the office of the Assam Public Service Commission, Khanapara, Guwahati-22 by hand only.
- 6) The selected firm will have to enter into an agreement before commencement of the work.
- 7) The agreement shall be ceased at any point of time if the selected firm fails to meet the time bound and errorless printing works as desired by the Commission.
- 8) The firm should have a workshop/office preferably within greater Guwahati.
- 9) The rate furnished should be inclusive of GST and any other charges.
- 10)The tender should be accompanied by a demand draft for Rs. 5,000/(Rupees Five thousand) only in favour of "Secretary, Assam Public Service
 Commission, Khanapara, Guwahati" as earnest money payable at Guwahati. It
 should be attached with the tender documents, failing which the tender will
 be rejected. The earnest Money Deposit (EMD) shall be refunded to the
 unsuccessful bidders after awarding of the service contract to the successful
 bidders.
- 11) The agreement shall be valid for a one financial year.
- 12)No revision of rates shall be made at any point of time during the contract period.
- 13)The payment shall be made after completion of works only. No advance payment would be made in any case.
