## **NOTIFICATION**

In pursuance of Executive order No. PRD-12/73/2019-PRD(B)/126 Dtd 4<sup>th</sup> Aug/2020 issued by P&RD(B)Department in Compliance with the Hon'ble High Court Order Dtd 21/07/2020 passed in the matter of WP(C) No.2839/2020 "All Assam Accredited Engineers Association" represented by Shri Bulbul Das, Secretary AAAEA – Vs – The State of Assam and Others and as per provision of the "Assam Panchayat and Rural Development Officers(Technical) Service Rules,2015", the Commission decided to relax the upper age limit for the Posts of Junior Engineer (Civil) under P&RD Department related to Advt. No 03/2020 vide No. 18 PSC/DR-5/1/2020-2021 Dtd 24/06/2020 as given below –

- (i) 10(ten) years of age relaxation or relaxation will commensurate with the years of service put in the Panchayat & Rural Development Department as contractual Accredited Engineers whichever is higher.
- (ii) In case of eligible contractual Accredited Engineers who cross more than 6 (six) months of a consecutive years of service than it will be rounded off and counted as another one year in respect to Para(3) & Para(4) of the said Executive Order.
- (iii) The eligible contractual Accredited Engineers must possess a valid engagement letter (in original) from the Competent Authority of P&RD Department in order to avail of the preferences detailed at Para(3) & Para(4) of the said Executive Order.

The preferential benefits as mentioned at Para(3) & Para(4) of the said Executive Order will be applicable <u>only once</u> in case of an eligible contractual Accredited Engineers and same will not be applicable for further career progression of the employee, if selected or for other subsequent recruitment processes, if any in the department.

<u>Interpretation</u>:- If any question arises as to the interpretation of this order, the decision of the Govt. shall be final.

**Junior Engineer(Civil):-** The candidate should not be less than 21 years and more than 48 years. The upper age limit is relaxable :-

- (i) By 10 years for ST/SC Candidates i.e. upto 53 years.
- (ii) By 10 years for OBC/MOBC Candidates i.e. upto 51 years which was earlier 41 years as per Govt. Notification No. ABP 6/2016/9 Dtd: 25/04/2018.
- (iii) For person with disabilities (PWD) by 10years irrespective of SC/ST/OBC and General Catagory i.e. upto 58 years which was earlier 48 years.

The Above relaxation will only be applicable for the candidates working in Contractual Basis under Panchayat And Rural Development Department .

The intending candidates working under contractual basis including any other candidates within the upper age limit prescribed in the earlier advertisement mentioned above may submit their application form for the aforesaid post mentioned above upto 31st Aug/2020.

The other terms and conditions of the above mentioned Advertisement will remain the same.
