Kindly note that the candidates appearing for document verification **must bring the following testimonials in original along with self attested photocopies thereof for verification.**

- (i) Permanent residential certificate issued in Assam for educational purpose or Voter ID in the state of Assam.
- (ii) H.S.L.C marksheet and Pass certificate.
- (iii) H.S.S.L.C marksheet and Pass certificate.
- (iv) Diploma marksheet and Pass certificate.
- (v) Caste/EWS certificate (if applicable).
- (vi) e-Admission certificate issued for the (OMR) Screening Test held on 03-10-2021.

Candidates must ensure their attendance for Document Verification as per date and time mentioned above to be considered for selection to the aforementioned post.

In view of the ongoing COVID-19 pandemic, candidates are instructed to strictly adhere to the instructions mentioned below throughout the process i.e. during document verification in the waiting hall.

- i. Maintain social distancing.
- ii. Cover mouth and nose with mask.
- iii. Use of hand sanitizers/hand wash frequently.
- iv. Candidates who have taken atleast one dose of COVID-19 vaccine are not required to bring negative RT-PCR/RAT test report. However, they must bring hard copy of the vaccine certificate(s) with them for appearing in the said interview.
- v. Candidates who are yet to be vaccinated must bring an RT-PCR/RAT negative report with them at the time of interview. The RT-PCR test should be performed within 72 hours of the commencement of the interview while RAT should be performed within 48 hours of the commencement of the interview.

It should be noted that your application for the above mentioned post will remain under scrutiny of the Commission and as such, your candidature is liable for rejection, if any wrong information furnished by you in your application is detected at any stage even after the document verification also. The Commission may take any action as deemed fit and proper.
