PUBLIC NOTICE

Whereas the Assam Public Service Commission had published the advertisement (vide advertisement no.08/2020 dated 08.09.2020) for recruitment to the post of Assam Civil Service (ACS) and Allied Services under CCE, 2020 in pursuance of the Assam Civil Services CCE (Amendment) Rules, 2019. The aspirants will have to qualify in the C.C. (Mains) Examination in one of the three native languages-Assamese, Bengali and Bodo. However, candidates from Dima Hasao, Karbi Anglong and West Karbi Anglong Districts who had not studied any of these languages in school shall be exempted from appearing for qualifying language papers.

Whereas the Government of Assam also gave exemption from appearing in the qualifying language paper to the candidates belonging to the three districts of Barak Valley viz., Cachar, Karimganj and Hailakandi who did not have any these languages in High School Leaving Certificate Examination.

Whereas challenging the said exemption, three Writ Petitions namely (i) WP(C) no.28/2021 (BONDITA BORAH Vs. State of Assam & others), (ii) WP(C) no.5169/2020 (NAVIN KUMAR RAY Vs. State of Assam & others) and (iii) WP(C) no.5248/2020 (BONANI PRIYA RAJKONWAR Vs. State of Assam & others) are filed before the Hon'ble Gauhati High Court and the Hon'ble Gauhati High Court vide order dated 02.09.2021 passed in WP(C) no.28/2021 (Bondita Borah Vs. State of Assam & others) and other Linked Cases, was pleased to observe that those candidates who did not have any of the three languages (Assamese, Bodo and Bengali) in their High School and have been given exemption from appearing in the language paper in the Combined Competitive Examination, such as candidates belonging to Dima Hasao, Karbi Anglong and West Karbi Anglong districts as well as Cachar, Karimganj, Hailakandi districts, should be represented before this Court at least in their representative capacity.

Now, in compliance of the Hon'ble Gauhati High Court's order dated 02.09.2021, candidates belonging to Dima Hasao, Karbi Anglong and West Karbi Anglong Districts and of Barak Valley *viz.*, Cachar, Karimganj and Hailakandi are hereby informed about pendency of the aforesaid 3(three) Writ Petitions in the Hon'ble Gauhati High Court, so that they may implead themselves as party/participate in the aforesaid Writ Petitions and represent their cause/causes, either singly or in representative capacity, if they so desire.
