1. Original copies of all Academic Certificates along with corresponding Mark Sheets from HSLC onwards to Diploma issued by Boards/Councils/Universities etc.
2. HSLC Admit Card/Certificate in original as a proof of Age.
3. Caste Certificate (SC/ST(P)/ST(H)/OBC/MOBC)/EWS Certificate in original issued by competent authority wherever applicable.
4. Up-to-date Identity card/disability certificates in original in case of PWD candidates only issued by competent authority.
5. Permanent Residential Certificate/Employment Exchange Registration/Voter ID.
6. Any other Certificates/Documents that may be relevant for your candidature.

It should be noted that your application for the above mentioned post will remain under scrutiny of the Commission and as such, your candidature is liable for rejection, if any wrong information furnished by you in your application, is detected at any stage even after the interview also. The Commission may take any action as is deemed fit and proper.
