The candidates must join within 15 (fifteen) days from the date of issue of this order in the official website of A.P.S.C. failing which appointment order is liable to be cancelled.

The appointment is subject to production of Medical Fitness Certificate of Health (as per enclosed format).

Further, their pension shall not be governed by the existing Assam Services (Pension) Rules, 1969 and subsequent orders issued from time to time. So far as their pension and other retirement benefits are concerned, it will be governed by a new set of Pension Scheme formulated in line with the Contributory Pension announced by Govt. of India i.e. 'New Defined Contribution Pension Scheme, 2009' which states.

Before joining this service, they shall have to submit an undertaking along with the joining report as prescribed below:-

"I understand and accept that Government servant joining the service of the State Government on or after 1st February, 2005 shall not be governed by the existing Assam Services (Pension) Rules, 1969 and orders issued thereunder from time to time and that their pension and other retirement benefits will be governed by a set of new Pension Scheme formulated in line with the Contributory Pension of Govt. of India i.e. 'New Defined Contribution Pension Scheme, 2009'."

A separate copy of undertaking is enclosed herewith which is to be signed by the Government servant and to submit to the undersigned on the date of joining. In the event of the incumbent choosing to leave the job after joining the service a three months prior intimation has to be given in writing.

The appointment is, however, subject to receipt of notarized affidavit in the format as prescribed in O.M.No.ABP.78/2021/01, dated the 18-11-2021 (as per enclosed format).
